Rationale for Recommendation.

MedPlus has shown a strong breakout after a base formation, supported by dry volumes earlier, followed by fresh buying interest near the previous support zone. The stock has retested the breakout zone and reversed from there with good volume activity on the daily time frame. Moreover, the stock is trading above all EMAs. Sustaining above ₹840 suggests further upside toward the ₹887–898 levels. Buy on dips with a stop-loss near ₹821 to manage risk.
